**Sub: “Special Re-evaluation” drive for the ‘back papers’ of the students, who were declared as ‘FAIL’ in the odd semester examinations held in December, 2019**

**Sir/Madam,**

This is to inform you that, with the approval of the competent authority, a “**Special Re-evaluation**” drive will be arranged very soon by the Council for the diploma students, who were declared as “**FAIL**” in the odd semester examinations held in December, 2019 due to getting ‘**BACK**’ in different theoretical subjects. Students, who secured **Grade Point Average (GPA) above zero** in the odd semester examinations held in December, 2019 are only eligible to apply for the special re-evaluation of their back paper(s). Eligible students will be allowed to apply for re-evaluation of their **maximum three (03) ‘back’ papers**.

A link captioning “**Apply for Special Re-evaluation**” will soon be provided in the Home Page of the council’s website, [www.webscte.co.in](http://www.webscte.co.in). All eligible students who are interested for re-evaluation of their back paper(s) may apply online through Council’s website ([www.webscte.co.in](http://www.webscte.co.in)). Applicants have to pay a non-refundable Application Fee of Rs.100/- per subject through online mode (Debit Card, Credit Card, Net Banking or UPI) for special re-evaluation of their back paper(s). However, the application fee for any subject (s) will be refunded to those students whose obtained marks in those subject(s) will be modified after the special re-evaluation.

Principals/Officers-in-Charge of all concerned Institutions under the affiliation of this Council are requested to make above information available to their diploma students eligible to apply for the special re-evaluation and advise them to keep a close touch with the official website of the Council ([www.webscte.co.in](http://www.webscte.co.in)) for the latest updates on this matter.
